The Receiver now seeks this Court's approval to accelerate the date of the auction of the Palmer Home to November 25, 2013 to enable participation by a bidder who would not otherwise participate because the original auction date was too close to the end of the calendar year to ensure a closing before December 31, 2013. The Receiver believes that moving the date to enable the participation of that bidder will help maximize the amount received for the Palmer Home.

IV. CONCLUSION

For the reasons set forth above, the Receiver moves this Court to approve the acceleration of the date of the auction of the Palmer Home to November 25, 2013.
