The matter before the Court is the Fee Application for Receiver and Receiver's Counsel for Services Rendered From October 1, 2013 to March 31, 2014 ("Application") filed by R. Wayne Klein, the Court-Appointed Receiver of US Ventures LC, Winsome Investment Trust, and the assets of Robert J. Andres, and Robert L. Holloway on April 3, 2014. The Application came on for a hearing on May 20, 2014. David Castleberry appeared on behalf of the Receiver, who was also present at the hearing. No objections were submitted in response to the Application or at the hearing held on this matter. The Court has reviewed the Application and the exhibits submitted in support of the Application, and based thereon and for good cause shown,

IT IS HEREBY ORDERED that:


1. The Application for payment of fees and expenses is APPROVED. The fees and expenses incurred by Manning Curtis Bradshaw & Bednar LLC, as set forth in the

Application, are reasonable and necessary, and may be paid as an expense of administering the receivership estate.

2. The Receiver is authorized to pay Manning Curtis Bradshaw & Bednar LLC \$2,098.76 as reimbursement of expenses paid on behalf of the Receivership Estate and \$119,548.75 in fees for its services rendered for the benefit of the Receivership Estate from October 1, 2013 through March 31, 2014.
3. The Receiver is authorized to receive \$36,408.50 in fees for his services rendered for the benefit of the Receivership Estate from October 1, 2013 through March 31, 2014.
