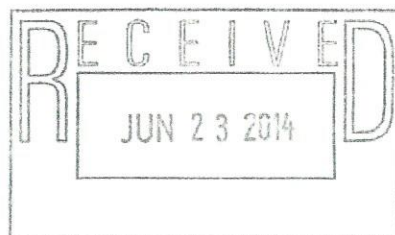

NOTICE OF APPEAL

PLEASE TAKE NOTICE that Appellant Terry Harper, in propria persona, hereby wishes notice to appeal; and/or if appropriate, to file Appellant's Combined Opening Brief and Application for a Certificate of Appealability to the TENTH CIRCUIT COURT OF APPEAL from the (order of judgment) in the UNITED STATES DISTRICT COURT, DISTRICT OF UTAH decision entered on (May 30, 2014 by Judge David Nuffer; and from Default Judgment in favor of R. WANE KLEIN as plaintiff.


Appellant Harper is legally blind and begs the honorable Courts' indulgence for any failure that may exist in his "papers" due to unfamiliarity with Appellate Rules of court and being visually challenged and uncertain of how to do certain tasks related to this process.

This appeal will contain substantive issues of "settled law", raised by Appellant Harper and ignored by plaintiff and the district court, regarding the foundational authority of Plaintiff to file a claim on which relief could be granted. Plaintiff's failure to comply with both "statutory", and "judicial" requirements contained in settled law as to specific prohibition and exemptions barring plaintiff's cause entirely. And thus, plaintiff cause

exceeded jurisdiction and the courts' authority under Title 25 Chapter 6 Section 9 25-6-9 and its protection.
