Pro se defendant Terry Harper appeals the district court's order denying his motion to strike the complaint. This court entered an order to show cause as to why the appeal should not be dismissed for lack of appellate jurisdiction. Mr. Harper filed a response. After considering his response and the applicable law, we now dismiss the appeal.

Mr. Harper appeals the May 14, 2013 order of the district court denying his motion to strike the complaint. The district court case remains ongoing. Neither a final order disposing of all claims against all parties nor a final judgment has been entered.

Except in circumstances not applicable here, this court only has jurisdiction to review final decisions of district courts. 28 U.S.C. § 1291. A final decision is one that fully terminates all matters as to all parties and causes of action and leaves nothing for the district court to do but execute the judgment. Quackenbush v. Allstate Ins. Co., 517 U.S. 706, 712 (1996); Harolds Stores, Inc. v. Dillard Dep't Stores, Inc., 82 F.3d 1533, 1541 (10th Cir. 1996). The district court's May 14, 2013 order is not a final decision. We therefore conclude that this court lacks jurisdiction to consider Mr. Harper's appeal at this time.
