The matter before the Court is the Fee Application for Receiver's Counsel for Services Rendered From December 1, 2012 through April 30, 2013 and for Receiver for Services Rendered From March 1, 2013 to April 30, 2013 ("Application") filed by R. Wayne Klein, the Court-Appointed Receiver of US Ventures LC, Winsome Investment Trust, and the assets of Robert J. Andres, and Robert L. Holloway on May 31, 2013. The Application came on for a hearing on July 9, 2013. No objections were submitted in response to the Application or at the hearing held on this matter. The Court has reviewed the Application and the exhibits submitted in support of the Application, and based thereon and for good cause shown,

IT IS HEREBY ORDERED that:


1. The Application for payment of fees and expenses is APPROVED. The fees and expenses incurred by Manning Curtis Bradshaw & Bednar LLC, as set forth in the Application, are reasonable and necessary, and may be paid as an expense of

administering the receivership estate.

2. The Receiver is authorized to pay Manning Curtis Bradshaw & Bednar LLC \$6,204.23 as reimbursement of expenses paid on behalf of the Receivership Estate and \$143,420.62 in fees for its services rendered for the benefit of the Receivership Estate from December 1, 2012 through April 30, 2013.
3. The Receiver is authorized to receive \$32.57 as reimbursement of expenses paid on behalf of the Receivership Estate and \$14,492.50 in fees for its services rendered for the benefit of the Receivership Estate from March 1, 2013 through April 30, 2013.
