Robert J. Andres ("Andres") and Robert L. Holloway ("Holloway") (collectively the "Receivership Defendants") and Defendant Winnie Chiu, to avoid prolonged litigation, hereby stipulate and agree that final judgment in favor of the Receiver and against Winnie Chiu may be entered as follows:

1. The Receiver and Winnie Chiu agree that the Court has jurisdiction over these actions and the parties involved in these actions.

2. The Receiver and Winnie Chiu acknowledge that they have read and agreed to the terms of this Consent Judgment, are aware of their right to a trial in these matters, and have waived that right.

3. The Receiver and Winnie Chiu state that they have entered into this Consent Judgment voluntarily.

4. Winnie Chiu states that between June 2006 and September 2009, she received direct payments or payments on her behalf from Winsome and its affiliated entities in the aggregate amount of \$110,000. Accordingly, the Receiver and Winnie Chiu affirmatively state and agree that Winnie Chiu is liable to the Receiver in this action in the amount of \$110,000.

5. Winnie Chiu does not admit or deny that Winsome and its affiliated entities operated as a Ponzi scheme; additionally, she does not admit the allegations in the Complaint, except for the jurisdictional facts necessary for the Court to retain jurisdiction over the parties for the enforcement of the judgment.

Therefore, judgment is hereby entered against Winnie Chiu in the amount of \$110,000.

7. This Consent Judgment shall take effect upon entry by the Court, and the Receiver and Winnie Chiu agree that the Court shall retain jurisdiction over Winnie Chiu for the purpose of enabling any of the parties to this Consent Judgment to apply for further orders and directions as may be necessary or appropriate to carry out or construe this Consent Judgment, to modify or terminate any of its provisions, or to enforce compliance.

8. This Consent Judgment shall not affect the Receiver's rights to pursue his claims against Warren Wai Hung Chiu, PacificWin Investments, Stephen Chiu or Jennifer Chiu. Nor will this Consent Judgment affect the Receiver's right to pursue his claims against any other entity or individual whom the Receiver has sued as part of his continuing duty to recapture and return investor funds that were sent to US Ventures and Winsome and then diverted by US Ventures and Winsome.


