**DECLARATION OF R. WAYNE KLEIN
IN SUPPORT OF SECOND MOTION FOR
REAPPOINTMENT OF RECEIVER**

I, Wayne Klein, depose and state under penalty of perjury as follows:

1. I am over the age of 18 years and have personal knowledge of the information contained herein, am competent in all respects to make this Declaration, and will testify to the same in a court of law if called to do so.

2. On January 25, 2011 in the above-captioned action, the Court entered an Order Granting Plaintiff's Ex Parte Motion for Statutory Restraining Order, Expedited Discovery,

Accounting, Order to Show Cause re Preliminary Injunction and Other Equitable Relief (the "SRO"). *See* SRO (Doc. No. 15).

3. As part of the SRO, the Court placed U.S. Ventures LC ("U.S. Ventures"), Winsome Investment Trust ("Winsome"), and all the assets of Robert J. Andres ("Andres") and Robert L. Holloway ("Holloway") (collectively the "Receivership Parties") under my control as Receiver. *Id.* at 9-13.

4. Within ten days of the Court's Preliminary Injunction Order, I filed copies of the Complaint and the Order appointing me as Receiver in the Southern District of California and the Southern District of Texas, where the CFTC had preliminarily identified property belonging to the Receivership Parties.

5. On February 28, 2011, the Court entered an Order of Preliminary Injunction and Other Equitable Relief Against U.S. Ventures and Winsome (the "Preliminary Injunction Order") in which it ordered that the SRO "shall remain in full force and effect until further order of this Court." Prelim. Inj. Order (Doc. No. 32).


6. On September 28, 2011, the Court entered an Order Reappointing Receiver. *See* Order (Doc. No. 77).

7. After my reappointment, I filed 40 Notices of Receivership in 40 different jurisdictions within 10 days of my reappointment.

8. Since my reappointment on September 28, 2011, I have become aware of other previously-unidentified property of the Receivership Parties located in six other judicial districts where I have not yet filed appropriate notices of the receivership, and also of claims for relief I may assert in those jurisdictions on behalf of the Receivership Parties.

I declare under criminal penalty of the State of Utah that the foregoing is true and correct.
