Pursuant to the Federal Rules of Civil Procedure 7, DUCiv 7-1(a) and 7-1(b)(1)(G), the Receiver in the above-entitled matter, R. Wayne Klein (the "Receiver"), by and through counsel of record, respectfully moves the Court to approve the Stipulation for Transfer of Assets to the Receivership ("Stipulation") according to the terms set forth therein. A copy of the Stipulation, executed by the Receiver and Defendant Laura A. Roser, is attached hereto as Exhibit A.

A [Proposed] Order Granting Motion for Transfer of Assets to the Receivership is attached hereto as Exhibit B.

The Receiver was empowered by the Court to enter into the Stipulation. The Order Appointing Receiver, Freezing Assets and Other Relief ("Order") dated April 11, 2011, gives the Receiver the authority "[t]o take custody, control and possession of all Receivership Property... from the Receivership Defendants..." and "to use Receivership Property for the Receivership Estates....." Order §8. The Order defines 'Receivership Property" to include all property owned directly or indirectly by Roser.

It is in the best interest of the receivership for the personal property of Roser to be transferred to the Receiver for liquidation. The proceeds from the sale will then be available to the Receivership estate.
