

Wayne Klein, Receiver*, together with all of the Exhibits attached thereto, all other papers filed related thereto, and applicable law. Based thereon, and for good cause appearing,

IT IS HEREBY ORDERED that:

- (1) The Motion is **GRANTED**;
- (2) The Settlement Agreement between William Carl A. Evans Testamentary Trust, Joseph W. Lindsey, and Theodore Lindsey (collectively, the "Evans"), on the one hand, and the Receiver, on the other hand, attached to this Order as Exhibit A, is **APPROVED**;
- (3) The Receivership Estate is deemed upon entry of this Order to have disclaimed, relinquished, and waived all interest, claim, title or right to the real property described in Exhibit B to this Order.
- (4) The stay of litigation imposed by the Order Appointing Receiver and Staying Litigation (Doc. 9) entered June 25, 2012 is hereby lifted with respect to real property described on Exhibit B hereto.
- (5) The Evans are deemed upon entry of this Order to have disclaimed, relinquished, and waived all interest, claim, title or right to the real property described in Exhibit C to this Order.
