The Matter before the Court is (1) the Combined Motion to Intervene and Lift Litigation Stay and Supporting Memorandum (the "Motion to Intervene and Lift Stay") (Doc. No. 427) filed by Paul Hawkins; (2) the Opposition to the Motion to Intervene and Lift Stay (the "Opposition") (Doc No. 449) filed by the Receiver; and (3) the Stipulation Resolving Receiver's Opposition to Combined Motion of Paul Hawkins to Intervene and Lift Litigation Stay ("Stipulation") (Doc No. 455) submitted by the Receiver and Paul

Hawkins. A hearing on the Motion was held on September 24, 2013 at 2:30 p.m. At the hearing, Richard R. Thomas appeared on behalf of Paul Hawkins, Chris Martinez appeared on behalf of the Receiver, and Ronald C. Barker appeared on behalf of Wayne Palmer. The Court has reviewed the Motion to Intervene and Lift Stay, the Opposition, the Stipulation, all papers filed and related thereto, and applicable law.

Based thereon, and for good cause appearing, IT IS HEREBY ORDERED that, based upon the foregoing, the Court GRANTS Paul Hawkins' Motion to Intervene and Lift Stay for the limited purpose of allowing Hawkins to proceed with his claims under the structure of the Stipulation presented by Paul Hawkins and the Receiver.
