The Motion to Intervene to Lift Injunction on Real Property Collateral of JPMorgan Chase Bank, N.A. (“Motion”) filed by JPMorgan Chase Bank, N.A. (“Chase”) came on regularly for hearing by the Court on November 10, 2014 after notice to the parties. James D. Gilson appeared as counsel for Chase; Sarah Goldberg appeared as counsel for the Receiver. Defendant Wayne LaMar Palmer was not present. The Court called Mr. Palmer’s phone number but there


was no answer. Having considered the memoranda of Chase and Palmer related to the Motion, and having heard oral argument from Chase's counsel,
