R. Wayne Klein, the Court-Appointed Receiver (the "Receiver") of National Note of Utah, LC, its subsidiaries and affiliates (collectively, "National Note"), and the assets of Wayne LaMar Palmer, by and through his counsel, hereby files this *Notice of Public Sale Results (Byron West Industrial Park Lot 5 Block 1)*. In support hereof, the Receiver states as follows:

1. On January 9, 2015, the Court entered an *Order Approving (1) Public Sale of Property Free and Clear of Interests, (2) Method and Form of Publication Notice, and (3) Public Auction Procedures (Byron West Industrial Park Lot 5 Block 1)* [Docket No. 854] (the "Sale

Order”), authorizing procedures for and the public sale of certain real property identified as 1419 Voll Dr. NW Byron, MN 55920, located in Byron, Minnesota (the “Real Property”) free and clear of interests. A legal description of the Real Property is set forth in the Sale Order.

2. Pursuant to the Sale Order, the Receiver provided notice of the auction via publication of the Court-approved notice in the *Salt Lake Tribune* and the *Byron Review* once a week for a period of four weeks prior to the public sale and on his website. A sale of the Real Property was conducted pursuant to the Court-approved “Auction Procedures” attached as Exhibit B to the *Receiver’s Motion and Memorandum in Support Requesting Order Approving (1) Public Sale of Property Free and Clear of Interests, (2) Method and Form of Publication Notice, and (3) Public Auction Procedures (Byron West Industrial Park Lot 5 Block 1)* [Docket No. 846]. Capitalized terms used hereinafter have the meaning attributed to them in the Auction Procedures.

3. No Qualified Bids were received by the Receiver prior to the expiration of the Bid Deadline, and accordingly, in accordance with the Auction Procedures, the Real Property was sold to the holder of the Stalking Horse Bid.

4. The sale of the Real Property to the holder of the Stalking Horse Bid has now closed. The property taxes and assessments owed were approximately \$45,000.00 higher than the gross sales price. This sale was able to be consummated only because the City of Byron voluntarily waived more than \$65,000.00 in taxes and assessments owed. In addition, the selling real estate broker voluntarily reduced his sales commission for this sale by 50%. The following is a summary of the results of this sale.

5. Because all outstanding taxes, assessments, and liens were paid at closing, the Receiver has deposited the Net Sales Proceeds in the Receivership Estate's Operating Account.
