The matter before the Court is the Receiver's *Motion Seeking Approval of Settlement Agreements with Turpin Parties and Green Apple Holding, LLC* [Docket No. 1248] (the "Motion"), filed by R. Wayne Klein, the Court-appointed Receiver (the "Receiver"), seeking approval of: (1) a settlement agreement with Michelle Turpin, P.C. and Michelle Turpin & Associates PC (the "Turpin Agreement"); and (2) a settlement agreement with Green Apple Holding, LLC (the "Green Apple Agreement").

A hearing on the Motion was held on January 13, 2017, at 1:30 pm (the "Hearing"). At the Hearing, Sarah Goldberg of Dorsey & Whitney LLP appeared on behalf of the Receiver, who was also present. No other parties appeared and statements were made on the record.

The Court has reviewed the Motion, the Declaration of R. Wayne Klein in Support of the Motion, all other papers filed in conjunction with the Motion, the statements made on the record at the Hearing, and applicable law.


Based thereon, and for good cause appearing,
