The matter before the Court is the Seventh Interim Fee Application for Receiver and Receiver's Professionals for Services Rendered From October 1, 2015 Through March 31, 2016 (the "Fee Application") filed by R. (2) The fees and expenses of the Receiver and his professionals Klein & AssociatesPLLC and Dorsey & Whitney LLP are ALLOWED on an interim basis as set forth in the FeeApplication;

(3) Klein & Associates PLLC is **ALLOWED** a claim in the total amount of \$129,552.50 for fees;

(4) Dorsey & Whitney LLP is **ALLOWED** a claim in the total amount of \$180,037.13 for fees and reimbursement of out-of-pocket expenses; and
