The matter before the Court is the Receiver's Motion Requesting Order Approving (1)

Public Sale of Property Free and Clear of Interests, (2) Method and Form of Publication Notice,
and (3) Public Auction Procedures and Memorandum in Support (Elkhorn Property) [Docket

No. 1178] (the "Motion") filed by R. Wayne Klein, the Court-Appointed Receiver (the

- 3. The method and form of the publication notice as set forth in the Motion are **APPROVED**. The following notice shall be published in *The Salt Lake Tribune*, a newspaper published in Salt Lake City, Utah, and in *The Idaho Enterprise*, a weekly newspaper published in Malad City, Oneida County, Idaho, once a week for a period of four weeks prior to the public sale:
