MOTION TO EXTEND SELF-SURRENDER DATE

The defendant, Wayne Lemar Palmer, by and through counsel of record, Robert K. Hunt, hereby moves the Court to extend the self-surrender date for approximately 90 days. In support of this motion, Mr. Palmer represents the following:

- 1. On October 9, 2018, Mr. Palmer was sentenced to Bureau of Prisons custody for 60 months. The Court allowed Mr. Palmer to self-surrender and ordered him to report to the designated facility by noon on January 17, 2019.
 - 2. Mr. Palmer seeks a 90 day continuance of his self-surrender date.

3. On November 17, 2018, Mr. Palmer was in a vehicle accident on 8900

South Redwood Road, West Jordan, Utah, when a vehicle crossed two lanes of traffic and

hit Mr. Palmer's vehicle broadside.

4. Mr. Palmer suffered, among other injuries, an acute fracture of the C-6

vertebrae, severe lacerations above and around his right eye, numerous displaced ribs,

damage to his right hip socket and damage to various nerve canals resulting in numbness

to his arms and hands.

5. Mr. Palmer has had various surgeries and is undergoing tests and

procedures to determine the extent of the numbness to his arms and hands. He is also

receiving ongoing physical therapy for the pain in his hip.

6. Mr. Palmer's physicians have scheduled appointments and procedures

through March 10, 2019. According to Mr. Palmer's physicians, the estimated date that

Mr. Palmer could leave their active care is 90 days, with an evaluation to follow.

Based on the foregoing, Mr. Palmer moves this Court to extend the date on which

he must report to the Federal Bureau of Prisons facility to April 17, 2019.
